Sub: Admission notice regarding Common Entrance Test (CET), Joint Entrance Management Aptitude Test (JEMAT) and Post Graduate Entrance Test (PGET) 2023-24.

Dear Sir/Madam,

I am directed to inform you that the University is going to conduct entrance examination for admission in Non-AICTE courses (UG/PG), MBA & MHA, M.Tech, M.Pharm & M.Arch courses offered by MAKAUT, WB( In-House) and its affiliated colleges.

Following Resolutions have been adopted from the University end:

1. The schedule of the Entrance Examinations are as follows:-

2. It has been resolved that students from all streams are eligible for all UG non-AICTE programs. However it is the responsibility of the colleges to ensure for the arrangement of Bridge courses, for the students from diverse academic background. The colleges have to certify that the bridge courses have duly been completed as per the student's academic requirement before the registration process/Enrolment process.
3. It was decided that MAKAUT, WB will follow the NEP 2020 guidelines from this academic year (2023-24) related to Curriculum and Credit framework as per which the programs would be designed with 4 years duration having exit option currently not before 3<sup>rd</sup> year.

4. It was resolved that CET/JEMAT/PGET college allotment will be done through online counselling after publication of results/rank cards.
5. The application fees for CET/JEMAT/PGET would be as follows: - Rs. 600/- for General and Rs. 300/- for Reserved (SC/ST/OBC-A/OBC-B) and PWD categories.
6. It was also resolved that the students will take admission in B.Voc courses through CET examination following NEP 2020 guidelines.
7. It was resolved that students can take admission in MBA and M. Tech courses in different affiliated colleges through CAT/MAT/GATE Examinations directly. Hence colleges have to report to the University about such admission before JEMAT/PGET counselling for preparation of seat matrix.
8. It was also resolved that for taking direct admission, students will have to pay the application fees @600/-.
9. Decentralized admission will be allowed after completion of CET/PGET admission process.

All colleges are requested to kindly note and make necessary arrangements in order to make the admission process a success.
