All applicants under [Case A] Establishment of New Institutions, [Case B] Introduction of Additional Course(s) of the existing affiliated Institution, [Case C] Variation in Intake in the affiliated Course(s) of the existing affiliated Institution, [Case D] Extension (Renewal) of Affiliation of the existing affiliated Institution, [Case E] Shifting of College-building of the existing affiliated Institution to the new premises, [Case F] Conversion of name and style of the existing affiliated Institution are required to note the said modification and the previous Information Brochure on **Guidelines and Other Terms & Conditions of MAKAUT,WB (Non-AICTE) Courses** (2024–2025) as notified vide Notification No. IC-297/2023/3717 dated 07.12.2023 **will not be taken into consideration henceforth**. In respect of the said Notification dated 07.12.2023 applications for [Case B] Introduction of Additional Course(s) of the existing affiliated Institution, [Case C] Variation in Intake in the affiliated Course(s) of the existing affiliated Institution, [Case D] Extension (Renewal) of Affiliation of the existing affiliated Institution, [Case E] Shifting of College-building of the existing affiliated Institution to the new premises, [Case F] Conversion of name and style of the existing affiliated Institution had already been submitted within 15<sup>th</sup> January, 2024. So, those applicants under [Case B], [Case C], [Case D], [Case E] and [Case F] need not apply again in respect of this Notification but the applications under [Case B] in response to Notification No. IC-297/2023/3717 dated 07.12.2023 will only be processed as and when NOC of the State Govt. in terms of Notification under Memo No. 44-Edn (T)/HED/20014(99)/14/2023-TECH dated 05.02.2024 will be submitted by the respective College to the University. The said Notification dated 05.02.2024 had already been circulated vide our Notification No. IC-299/2024/3750 dated 12.02.2024. Only application under [Case A] Establishment of New Institutions is being invited through this Notification.

The Society/ Trust/ Company as prescribed in the Information Brochure interested to apply under [Case A] is required to submit application within the stipulated time frame under Clause 3 of Information Brochure on Guidelines and Other Terms & Conditions of MAKAUT,WB (Non-AICTE) Courses.

**The NOC as prescribed vide Notification No. 885-Edn.(CS)/OM-152L/2012 dated 17.09.2015 read with the Notification under (i) Memo No.412-Edn(T)/HED-20014(99)/14/2023-TECH dated 14.09.2023 and (ii) 44-Edn (T)/HED/20014(99)/14/2023-TECH dated 05.02.2024 of the Department of Higher Education, Govt. of West Bengal is MANDATORY for submission of application under [Case A]. If any application under [Case A] is received without NOC of the State Govt., the said application will not be processed.**
