Sub: Uploading of mandatory survey data for 2017-18 on AISHE portal

As you are aware that Ministry of Human Resource & Development, Government of India, conducts All India Survey on Higher Education every year through a web portal.

You are requested to arrange uploading of DCF-II form by college-officer for the year 2017-18. The college-officer must login to <http://aishe.nic.in> and download DCF-II. After filling it up with data he must upload the file in the same portal. Those who have previous years login should login using login details. In case the details are lost the college-officer must click 'Forget login details' and recover the details. The first time users should click 'New User' and register themselves before the downloading and uploading process. **Please upload the data as early as possible. The uploading of survey data has been made mandatory by the government, UGC, AICTE, MCI etc. for all institutions which pertains with +2 education.**

No hard copy is required, only the filled up pdf form file has to be uploaded to the above mentioned portal. Please do not send emails after successful uploading. All activities done on the portal are transparent on each level.
