#### Eligibility Criteria:

An eminent scholar with consistently good academic record and a Ph. D. degree in Computer Science & Engineering/ Information Technology with adequate evidence of knowledge and research in Information and Communication Technologies with a number of high quality research publications in reputed journal and / or publication of books.

#### Desirable Experience:

The applicant should with an established record of teaching or industry experience, an exceptional record of published research in high quality journals, including guidance of Ph.D. students and demonstrated ability to attract significant research funding as well as having an ability to lead teams in multidisciplinary projects. The incumbent is also expected to serve as mentor to junior faculty members and to the students.

# **Desired Expertise:** Artificial Intelligence / Data Science / Information Security / Internet of Things and other latest cutting edge technologies

#### Appointment:

- The faculty member "appointed against the Chair" will be called "JIS Chair Professor" and will receive a monthly salary
- The "appointment" against the Chair will be normally made for a period of one year, extendable if performance is satisfactory.

**3.** The hard copy of the Application must reach the office of the Registrar within along with a **Demand Draft of Rs. 1000/- in favour of Maulana Abul Kalam Azad University of Technology, West Bengal, payable at Nadia.** 

4. Envelope must be properly superscribed with the post applied for as "Application for the post of JIS Chair Professor (Contractual)"

**5.** One set of self – attested photocopies of all relevant documents must be submitted along with the application.

6. Application forms submitted by the applicants must be properly filled in all respect and all the entries therein must be substantiated by supporting documents without which such applications would be treated as invalid. It is to be noted that applications without application fee would be rejected.

- 7. Already employed applicants should apply through proper channel.
- **8.** Appointments will be made for one year on contract which may be extended depending on the assessment of performance of the incumbent during the contractual period as well as the need of the University.
- **9.** The University may verify the antecedents or documents submitted by a candidate at any time including at the time of appointment or during the tenure of his/her service and in case it is detected during the time of recruitment process and also at any point of time after the appointment that the documents submitted by the candidate are fake or the candidate has deliberately misled by submission of fake/ forged documents, his candidature/ service will be forthwith canceled/ terminated without assigning any reason.
- **10.** Incumbents to be appointed on final selection to this post are liable to be deputed amongst different locations of the University.
- **11.** Incomplete application will not be entertained.
- **12.** University Authority will not be responsible for any postal delay in case receipt of application by the University or receipt of Interview call letter by the applicant.
- **13.** No TA/DA shall be paid to candidates for attending interview.
- **14.** Only the selected candidate in respect of the aforesaid post will be intimated accordingly.
- **15.** Canvassing in any form will lead to the cancellation of the candidature.
- **16.** The University reserves the right not to fill up the post advertised without assigning any reasons.
- **17.** In case of any dispute the decision of the University will be final.
