NOTICE

The inconveniences due to the year lag in accordance with Rule 6, Part 2, Chapter IV, First Regulations, WBUT and Rule 6, Part 2, Chapter III, First Regulations, WBUT (formulated by the Academic Council in its meeting held on 09.10.2009) faced by a large number of students undergoing their study different semesters under different B.Tech/B.Pharm/B.Arch/B.Optom/BHM & other four year degree programme and BBA, BCA, MBA, MCA, and MCA(Hons) in the affiliated colleges of this university were brought to the notice of the university Authority time to time from different quarters including the guardians and other stakeholders of the higher education. The question of modification of those rules without compromising the quality of education was under active consideration of the University Authority for some time past.

After careful consideration of the matter the Academic Council in its meeting held on 29.11.2013 has framed the rules pertaining to the year lag of students undergoing the aforesaid courses in exercise of the power conferred under Regulations 6.3 of Part 1, Chapter II of First Regulations, WBUT and those have already been notified vide Notification No. 07/Regis/Aca.Council/2013 dated 02.12.2013. Those rules have been framed in partial supersession/modification of Rule 6 of Part 2, Chapter III and Rule 6 of Part 2, Chapter IV of First Regulations, WBUT and are not inconsistent and/or repugnant with the Academic Regulations under Chapter II, Part 1 of the First Regulations governing academic and associated activities.

So it is made clear that a student shall be eligible for promotion to the next higher level/year with back logs but those back logs are to be cleared within the time limit specified for the completion of the course as prescribed under the First Regulations, WBUT. As the rules framed by the Academic Council in its meeting held on 29.11.2013 will come into force with effect from 01.01.2014, the year lag students of **Odd Semester** who will be eligible for promotion to the next higher level/year due to partial modification/supersession of relevant rules will appear in special examination to be held in the month of February, 2014. The academic requirements of the students pertaining to this special examination are to be fulfilled in the intervening period by the respective colleges. Moreover, the assessment of sessional items (practical and theory both) is to be submitted to the Controller of Examinations of WBUT prior to the commencement of the examination.

All concerned are to note and act accordingly.
