- 3. The hard copy of the Application must reach the office of the Registrar within 14/12/2018 along with a Demand Draft of Rs. 1000/- in favour of Maulana Abul Kalam Azad University of Technology, West Bengal, payable at Nadia (Rs.500/- for SC/ST/OBC/PH category).
- 5. The applications must be sent in different envelopes for different posts.
- 6. One set of self attested photocopies of all relevant documents must be submitted along with the application.
- 7. Application forms submitted by the applicants must be properly filled in in all respect by the applicants concerned and all the entries therein must be substantiated by supporting documents without which such applications would be treated as invalid. It is to be noted that applications without application fee would be rejected.
- 8. Already employed applicants should apply through proper channel.
- 9. In this advertisement notice, the term "Higher Educational Institute" connotes to educational institutions belonging to the level of colleges or universities duly recognised by the competent authority (ies).
- 10. The University reserves the right to determine the number of candidates to be called for interview.
- 11. Appointments will be made on probation for one year which may be extended depending on the assessment of performance of the incumbent during the probation period.
- 12. The University may verify the antecedents or documents submitted by a candidate at any time including at the time of appointment or during the tenure of his/her service and in case it is detected during the time of recruitment process and also at any point of time after the appointment that the documents submitted by the candidate are fake or the candidate has deliberately misled by submission of fake/ forged documents, his candidature/ services will be forthwith cancelled/ terminated without assigning any reason.
- 13. The prescribed essential qualifications/experience indicated above is bare minimum and mere possession of the same will not entitle the candidates to be called for interview. It is also to be noted that the University reserves the right to raise the cut-off level of eligibility criteria beyond those indicated under the "Essential Qualifications" for the respective posts. The University will have the right to restrict the number of



candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed and/ or by arranging a screening test as may be deemed fit.

- 14. All the posts (Serial no. 1 to 4) advertised are sanctioned by the Govt. of West Bengal. The age of superannuation for the incumbent appointed to the post of Registrar (Sl. No. 1) would be 62 years or as may be notified by the Govt. of West Bengal from time to time. For all other posts (Sl. No. 2 to 4) the age of superannuation for the incumbent appointed to these posts would be 60 years or as may be notified by the Govt. of West Bengal from time to time.
- 15. All the incumbents to be appointed on final selection to these posts are liable to be transferred amongst different locations of the University.
- 16. A relaxation of 5% in marks (wherever necessary) may be provided for candidates (applicable for candidates domiciled in West Bengal) belonging to SC/ST/OBC/Differently abled (physically as well as visually) categories.
