Infinity corrected Optical System Trinocular (three step light path divider) Research Upright Microscope with True Koehler Illumination of 14Watt high power LED for Transmitted light illumination (Lamp Life (minimum: 60,000 hrs), Light Intensity LED indicator, Light pre-set switch, highly ergonomic Design for user comport. Microscope should be upgradable to fluorescence and DIC function in future. 360 degree circular rotatory stage capable of fitting with hot and cold stage (temperature up to 300 °C) structure.

TRINOCULAR TUBE:

Wide field (Field. No. 22mm or better) Trinocular tube with 3 step Light path selector knob (100:0, 20:80, 0:100) with adjustable interocular distance. Three position prism Trinocular tube, 100% light for viewing, 20% - 80% viewing & photography, 100% light for photography.

<u>STAGE</u>: Circular centering type rotatable stage, the edge graduated in 360 degree vernier reading to 1/10 degrees. Compatible to Hot and cold stage temperature up to 300 degree C and with cooling option for future.

CONDENSER:

Abbe condensers (NA 0.9) for 1.25X to 100X. Dust Cover for Microscope and adapter for compensators. Quarter Wave Length Plate (01) and Tint Plate (01).

OBJECTIVE:

Plan Semi Apochromate objective 10X/NA0.25

Long working distance M plan semi apochromate 20X objective with N.A 0.40 and free working distance of 12.0mm & Long working distance M plan semi apochromate 50X objective.

Polarizer and analyzer attachment for transmitted light: Polarizer Slider (01). Rotating Stage for Polarization. Attachable Mechanical Stage. Polarizing Condenser (01).

Intermediate attachment for analyzer, Polarizer and 360 degree Rotatable Graduated Analyzer. Microscope should have the option to attach High definition camera (for capturing image at a certain temperature) for future provision to serve the purpose.

At least 12 months warranty from the date of installation and the installation to be done at Main campus (Haringhata, West Bengal) of the University at free of cost. The total price must contain the supply, installation and training. Full payment to be made after the satisfactory installation process (also training if associated).

PART-E: GENERAL TERMS & CONDITIONS

- 1. The bidder should be a registered firm under prevailing rules having an office in West Bengal, preferably in Nadia, North 24 Parganas or Kolkata and will provide essential registration numbers like PAN, GSTIN, Profession Tax, etc.
- 2. The web tendering process will be two-stage bidding: (a) Technical and (b) Financial.
- 3. In order to maintain the confidentiality, the financial bid (BoQ) must be a password-protected file. The bidders have to send both Technical and Financial bids to purchase@makautwb.ac.in mail address and the password of the password-protected financial bids file to registrar@makautwb.ac.in mail address.
- 4. Those bidders who have already participated in 1st call will again have to participate in this tender and the tender fee for the 1st call will be valid for 2nd call i.e. the bidders may not deposit the tender fee for 2nd call.
- 5. Any firm already having any legal dispute with the University need not to submit the bid.
- 6. Apart from the above list mentioned in Part-C of this tender notice, the University may ask the bidder forany other document(s) / information, if feels necessary. The bidder has to furnish the document(s) / information immediately failing which his bids will be rejected.
- 7. All the documents should be authenticated with official stamp and signature / signatures thereon by the bidder.
- 8. Submission of false document(s) / information by the bidder will result into cancellation of bid and theUniversity maytake strict action against that bidder.
- 9. Any document sent in .jpeg / .jpg / .doc / .docx / .xls / .xlsx format will not be accepted.
- 10. The University reserves the right to accept or reject any bid without showing any reason.
- 11. Any dispute which may arise between the bidder and the University regarding this bidding shall be referred to the Vice Chancellor of the University whose decision shall be final and irrevocable in this regard.
- 12. Being the lowest bidder (L1) in term of quoted amount (incl. all) may not be the only condition to receive the order, other criteria like having PAN, GSTIN, location of office, etc. may also be considered during selection of the eligible bidder. Decision of the University in such case will be the final.
- 13. In case the selected bidder is unable to supply the items after being selected to supply the items or afterreceiving the respective order from the University, the bidder should immediately inform the University Authority about the same by e-mail. Decision of the University in such case will be the final.
- 14. Delivery of the items to the destination is solely the bidder's responsibility and no extra charge will be paid by the University for the same. Any damage of the item during transit will be the responsibility of thebidder.
- 15. Govt. levies will be as per existing Government Rules. The University will provide DSIR Certificateagainst which all permissible tax relief has to be ensured.
- 16. If any vendor is registered under GST Composite Scheme, the same is to be mentioned in Part-C (ItemNo.4). The same may also be mentioned in the BOQ.
- 17. Payment will be subject to successful delivery and installation of the required items and necessary approval of the Competent Authority of the University. No additional payment will be made by the University towards installation charges.
